

WA protocol for accessing immunoglobulin blood products for public health use in Western Australia

Information for public health access to immunoglobulin products in Western Australia

This document describes the process for accessing immunoglobulin blood products for post-exposure prophylaxis (PEP) for public health disease control activities in Western Australia.

Normal Human Immunoglobulin (NHIg) and Zoster Immunoglobulin (ZIg) supply is governed by the National Blood Authority, and NHIg and ZIg is supplied by the Australian Red Cross Lifeblood Service.

Human Rabies Immunoglobulin (HRIg) supply is governed by WA Health Public Health Physicians (PHPs) and the Communicable Disease Control Directorate (CDCD).

The process for accessing each product and how to order or access WA Health cache stock *(Appendix I)* where held, is outlined below. Refer to Further Information section as required.

1. Process for HRIg

This is an overview only. For detailed instructions please refer to <u>Rabies and other lyssaviruses (including</u> <u>Australian bat lyssavirus) (health.wa.gov.au)</u>

All cases of possible exposure to rabies or other lyssaviruses (including Australian bat lyssavirus) require completion, under <u>PHP</u> guidance, of an <u>exposure assessment</u> and <u>product order form</u>.

- The PHP approves the use of HRIg and rabies vaccine by providing their name as the approver on the order form. This authorises the distribution of the required HRIg (and rabies vaccine) *either* direct to the location where the case will be seen, *or* it authorises the use of cache stock and replacement of those products, to maintain cache stock levels. See Appendix 1 for list of cache sites.
- 2. The PHP sends the order form to Onelink to replenish cache stock and <u>confirms all orders by</u> <u>telephone</u>, as the email and phone number details vary during and outside office hours.
- 3. The PHP sends a copy of both the <u>order form</u> and the <u>exposure assessment</u> form to <u>vaccineorders@health.wa.gov.au</u> for recording purposes.

CDCD's vaccine management team oversees the process of despatching rabies PEP via Onelink, conducts routine checks of cache stock at each approved facility and maintains case records.

2. Process for NHIg

For REGIONAL orders where NHIg cache stock is held:

- 1. The PHP completes the <u>NHIg order form</u> to approve release of cache stock that is positioned in regional hospitals.
- 2. The PHP ensures the 'in-hospital stock' option is 'ticked' and the hospital delivery address is entered, so that NHIg cache stock is replenished.
- 3. The PHP sends the completed form to the WA contact details shown on the NHIg form.
- 4. For urgent requests, the PHP must phone Lifeblood on 9325 3030 <u>after</u> the form has been sent.



For REGIONAL or METROPOLITAN orders where NHIg is not held:

- 1. The PHP or the treating physician completes the <u>NHIg order form</u> with the required delivery address.
- 2. The PHP sends the completed form via the WA contact details shown on the NHIg form.
- 3. For urgent requests, the PHP must phone Lifeblood on 9325 3030 <u>after</u> the form has been sent.

Lifeblood will release and deliver products in accordance with the delivery address and instructions noted on the form.

The PHP must include their personal emergency contact details for any queries that may arise.

3. Process for ZIg

The treating clinician (provider) can liaise directly with the Australian Red Cross Blood Service in WA (Lifeblood) by phoning the **24 hour service on 9421 2800 and provide details of** the case and provider delivery details.

Lifeblood will act quickly to review the patient case details and ascertain if ZIg is required, and the best process for access.

The PHP may provide advice and support to the provider in this process, as necessary.

Lifeblood will either:

- confirm that the provider is an Approved Health Provider (AHP) and request that the provider submits the ZIg order through their National Blood Authority <u>BloodNet</u> system account, or
- if not an AHP, send the provider a manual form to complete (document number FRM-00144). Lifeblood will liaise directly with the provider and create a new AHP retrospectively where applicable.

Lifeblood will review, approve and package the ZIg ready for pick-up.

For routine orders, Lifeblood has regular courier runs to most Perth metro hospitals Monday to Saturday, and to regional hospital pharmacies overnight.

For urgent and life-threatening orders, Lifeblood will request that the provider (or support by the PHP on behalf of provider) arranges product collection from 290 Wellington Street to be couriered to their premises, at the cost of the provider (or PHU).

Where ZIg is not approved (or unavailable), Lifeblood and the provider will liaise regarding an alternative treatment, and the PHP may be consulted further.

Note: PHPs would only need to have their own AHP account if there is an ongoing requirement for direct administration to patients by the PHP/PHU.


